Dear Colleagues,

I am delighted to see you have been awarded an additional £600M from the Spending Review to spend on evidence-based talking therapies. But how will you get to see any of that additional funding make a real difference to patients?

No one has worked harder in achieving improved access to psychological therapies since the transition to NHS England than yourselves. The NHS is seen as a world class service in respect of the way we have transformed evidence-based talking therapies since 2007. We are about to see the launch of the Mental Health Task Force report, led by Paul Farmer CBE and Jacqui Dyer. This will set out an expanded scope and clear ambitions for what NHS psychological therapy services are expected to achieve by 2020. I am delighted that they are opening our 2-day conference to set this out in detail with Karen Turner, National Director for Mental Health and Dr. Matthew Patrick, Chief Executive, South London and Maudsley NHS Foundation Trust (see <a href="https://www.newsavoypartnership.org">www.newsavoypartnership.org</a> for the full programme).

The reason that I am writing to you is because I want to ensure as many of you as possible can attend our annual conference this year **together**. Therefore we are offering a number of funded FREE places for IAPT Clinical Leads/Managers and commissioners. What I want is for the people who must translate these ambitions into reality to be able to have a meaningful dialogue with national leaders, including with the Government Minister with direct responsibility for mental health, **Rt. Hon. Alistair Burt MP**, as well as the Opposition spokesperson, **Luciana Berger MP**, in a Question Time session chaired by **Mark Easton** from the **BBC.** Likewise, on day 2, we need to have a robust conversation with the Government Minister with responsibility for welfare reform, **Lord Freud** who will be joined for the Any Questions session by **Theresa Grant, Chief Executive Trafford Council** from Greater Manchester Combined Authorities to discuss how a joined-up approach to mental health is vital if we are to deliver all this **and also make welfare savings.** We are also expecting confirmation from a senior spokesperson from the Opposition.

You will also see that we are launching a **Staff Wellbeing Charter** to ensure the people who are on the frontline trying to deliver all this are being properly supported in their work – which the results of our staff survey show otherwise.
